AC/DC DIELECTRIC TESTING

The inspection of the upper and lower boom including fiberglass, hoses, leveling system, etc. is performed to locate defects that may cause a free fall, free rotation and/or dielectric failure. A dielectric test of the upper boom, lower boom insert, bucket liner and hydraulic oil is done in compliance with ASNI A92.2-1990 and ASTM D877.

VISUAL & OPERATION INSPECTION

This inspection includes a visual/operational inspection of all critical, structural areas. All suspect areas are examined further by utilizing the following NDE methods: magnetic particle, ultrasonic and dye penetrant inspections in accordance with ANSI A92.2 and OSHA 1910-1926.

ACOUSTIC EMISSION (AE) TESTING

AE testing is performed in compliance with latest ASTM F914, F1430, and F1797 Test Standards. The data is interpreted and recorded by a Level II AE Technician. Visual and operational inspection is performed prior to AE test.

COMPLETE INSPECTION

We also offer a complete inspection, which includes all available inspections, test methods and procedures as mentioned above.
